



Limited Warranty

Terms and Conditions of Workspace48's five (5) Year Limited Warranty - Your warranty begins at the date of purchase, please retain your proof of purchase. The warranty coverage only covers the original owner. The replacement of any part is warranted for the remainder of the original warranty period.

What is Covered - The parts are warranted for a 5-year period from the date of purchase. Workspace48 will provide replacement parts for any original defects, when the device is assembled and installed in accordance with the owner's manual and installation guide. This limited warranty is also subject to your compliance of the attached User Terms.

What is Not Covered - Any damage to the product caused by accident, negligence, misuse, vandalism, external sources like weather, transit, floods or the negligent use of parts not installed or assembled in accordance to the instructions of Workspace48. Using components which are not Workspace48 parts. Labor for replacement parts. If installed outdoors or in a corrosive or wet environment containing hazardous chemicals. Damages caused by cleaning not in accordance with this instruction manual. Any loss of business, revenue, or personal injury as a result of the product failure, accident, abuse, or misuse.

Warranty Limitations and Exclusions - This limited warranty negates or limits all other warranties, expressed or implied, except those limited by the laws of the state in which the product is used (and then only limited to the duration of this limited warranty). The greatest extent permitted by law Workspace48 will not be liable for consequential, incidental, and any special damages to persons or property that you may incur in connection with your Pedal Activated Hand Sanitizer Stand product.

User Terms

The SaniStep Pedal Activated Hand Sanitizer Stand is not to be used in conjunction with any other types of post systems such as but not limited to theater ropes and pedestrian traffic stanchions and the like. Always install the device in a well-lit area and never place it directly in the path of a doorway or elevator. Never use the Pedal Activated Hand Sanitizer Stand for purposes other than its intended purpose of dispensing hand sanitizer – such as propping doorways open or supporting any other objects off the ground. The device was not designed to support the weight of a human - never allow anyone to climb in or around the Pedal Activated Hand Sanitizer Stand. If attempting to secure the product to a floor by means of fasteners, be sure the floor is free of any electrical conduits or electrical lines. Follow assembly instructions carefully – failure to do so may result in injuries to users.

Routinely inspect all fasteners and tighten if necessary. If the Pedal Activated Hand Sanitizer Stand wobbles after tightening or the lever is damaged, immediately take the device out of service. Never dispense any other forms of liquids besides hand sanitizer from the Pedal Activated Hand Sanitizer Stand. This device is not intended to serve as an eyewash or safety cleansing station for treatment of exposures to acutely hazardous materials or chemicals. Routinely inspect the floor area directly beneath the Pedal Activated Hand Sanitizer Stand for spillage and clean up immediately to prevent users from slipping while using the device. Also, occasionally inspect the hand sanitizer bottle itself for leaking to prevent any sanitizer from making its way down the post and onto the floor. When operating the Pedal Activated Hand Sanitizer Stand, always use closed-toe shoes and do not place feet or hands under the pedal when in use. Only use soap and water to clean the device – never use any chemical that can pit or damage the post and parts.
